

ROCB A/P Annual Work Plan 2016/2017

In accordance with the ROCB A/P's Terms of Reference, the ROCB A/P is supposed to develop its 2-year term Strategic Action Plan and Annual Work Plan for the purpose of assuring its work accountability and governance to the regional Directors General. The Plans are to be worked out in close consultation with the Regional Vice-Chair with the intent of assuring effective use of limited resources and making the region's capacity building more focused and relevant to the needs of the regional Member Customs administrations. To this end, in the course of devising the ROCB A/P's Annual Work Plan, Regional Training Coordinator (i.e. Japan Customs) and the ROCB A/P jointly conduct an Annual Technical Assistance Needs Survey each year. As such, the ROCB A/P's Strategic Action Plan is closely linked with the incumbent A/P Regional Strategic Plan. The ROCB A/P's Annual Plan for 2016/2017 was subsequently approved by the WCO Capacity Building Directorate in early August 2016 and made open to the Member administrations in the A/P region and general public on the ROCB A/P's homepage (www.rocb-ap.org) under "Resources" column. The updated Strategic Action Plan for 2016-2018 and the Annual Work Plan 2016/17 are appended to this E-Newsletter as **Appendix 1** and 2 respectively.

The Annual Work Plan for 2016/2017 accommodates quite a good number of the regional/sub-regional and national workshops, both newly funded and carried forward from the previous years. These workshops seek to support improvements in the following 5 core Customs functions, namely: (1) Supply Chain Security; (2) trade facilitation; (3) revenue; (4) compliance and health and safety protection; and (5) organizational development, and they focus on implementation

of a series of internationally-recognized good practices for Customs reform and modernization.

Regional Training Centers (RTCs) play key roles in delivering planned regional/sub-regional workshops for the interest of the Member Customs administrations in the A/P region. Accordingly, the ROCB A/P has also consulted the WCO Secretariat and RTCs and coordinated the dates and venues of the most of these capacity building programs. ROCB A/P participates in the Customs-Business Conference

7 July 2016, Bangkok, Thailand

At the invitation of the Thai Customs Department (TCD), Ms. Pariyabhat Ariyapongkoson and Mr. Kangsik Cho of the ROCB A/P attended the Customs-Business Conference held on 7 July 2016 in Bangkok, Thailand. Approximately 120 representatives from private and public sectors, embassies, Chamber of Commerce, relevant international and government agencies, as well as TCD officials participated in the Conference. It was the first event of this kind aiming at

publicizing information about updates of Customs laws and regulations and privileges (such as Customs Incentives Schemes, Authorized Economic Operator (AEO), Advance Tariff Ruling (ATR)), as well as the National Single Window and Mobile Applications, which are of benefit to businesses in Thailand as well as foreign trading entrepreneurs doing business with Thailand.

ROCB A/P represented the WCO to the ASEM Eurasia Expert Group Meeting

11-13 July 2016, Seoul, Korea

Ms. Alpha WONG of the ROCB A/P, as a WCO representative, attended the ASEM Eurasia Expert Group Meeting on Transport and Logistics, which was held on 11-13 July 2016 in Seoul, Korea. Approximately 400 delegates, including government officials from ASEM member countries and Eurasian countries, representatives from international organizations, institutions, industries and academia in the areas of transport and logistics, participated in this Meeting.



This Expert Group Meeting was proposed by the President of Korea at the last year's ASEM Symposium on Transport and Logistics Network held in Seoul, Korea (please refer to the ROCB A/P's homepage at

http://www.rocb-ap.org/article-

detail/170/?crmid=tt0ov6096qhr5fkdve6h7j3ks4). It aimed to provide a platform for the delegates to discuss the establishment of multi-modal transport and logistics network between Asia, in particular starting from Korea, via China, Russia and connecting to Europe. At the opening ceremony, Mr. Kang Hoin, Minister, Ministry of Land, Infrastructure and Transport of Korea delivered a key note address and stressed the economic benefits on the integrated transport networks for connecting Asia and Europe, in particular by railway and road. During the Meeting, speakers raised the awareness on multilateral cooperation and



harmonized Customs standards for seamless cargo and passenger flow. In this regard, WCO's SAFE Framework of Standard was referred and duly recognized as one of the key guidelines and tools to be taken into account for their future design of the integrated transport network with assurance of facilitating trade and securing supply chains.



127th/128th Sessions of the WCO Council

14-16 July 2016, Brussels, Belgium

The 127th/128th Sessions of the WCO Council were convened on 14-16 July 2016 at the WCO Headquarters in Brussels, Belgium, and were attended by a total of around 500 delegates from the WCO Member administrations, the observer international organizations and business associations. Mr. Kazunari Igarashi, Head of the ROCB A/P, attended the Council as an



observer. The Council heard about the series of activities undertaken by the WCO and new tools and guidelines developed by its committees, which were adopted subsequently. The Council also discussed the way forward on a number of topical subjects such as Digital Customs, e-commerce, governance issues, Customs-Police cooperation, Customs-Tax cooperation, security initiatives, and the Customs roles in protecting cultural heritage, among other things.



In the course of the Council Sessions, there was a regional consultation session for the respective WCO regions, including one for the A/P region, in where the hand-over of the regional Vice Chairmanship from Malaysia to Fiji was made. The ROCB A/P is grateful to the Royal Malaysian Customs Department (RMCD) and the fellow colleagues of the



Vice Chair's Secretariat for their great contribution to the A/P region and to the whole international Customs community through the leadership of the RMCD Director General, Dato' Sri Khazali bin Hj Ahmad, as well as their guidance and collaboration with the ROCB A/P during their 2-year long tenure as the Vice Chair. The ROCB A/P looks forward to continued collaboration with incoming Regional Vice Chair, Fiji, for the next 2 years. In the margin of the Sessions, Mr. Igarashi saw several Directors General/ Commissioners and Secretariat officials and discussed/coordinated the Annual Work Plan and preparation of the upcoming regional/national workshops.





WCO Sub-regional Workshop on Integrity for the Pacific

27-29 July 2016, Suva, Fiji



The WCO, in cooperation with the ROCB A/P, Fiji Revenue and Customs Authority (FRCA) and Oceania Customs Organization (OCO), organized the Subregional Workshop on Integrity for the Pacific on 27-29 July 2016 at the Regional Training Center Fiji, in Suva, Fiji, under the sponsorship of Japan Customs Cooperation Fund (CCF/Japan). A total of 23 high-level officials from the WCO Member Customs administrations in the Pacific region and 6 resource speakers, including Dr. Kunio Mikuriya, WCO Secretary General, and Dato' Sri Khazali bin Hj Ahmad, Director General of the Royal Malaysian Customs Department (RMCD), participated in this important Sub-regional Workshop. In addition, 11 high-level representatives from the OCO Member administrations, who are not WCO Member administrations, took part in the Workshop with sponsorship of the OCO. Mr. Kazunari Igarashi, Head of the ROCB A/P, joined the Workshop as a facilitator.



Workshop was opened with the remarks by Mr. Visvanath Das, Acting Chief Executive Officer of the FRCA and Comptroller of Customs, which highlighted ramifications of integrity to border security and trade facilitation, as well as the entire Customs reform and modernization process, and underlined the Customs mangers' engagement to contend with a series of challenges through multi-faceted measures. The Workshop was led by the resources persons from the WCO Secretariat and Mauritius Revenue Authority (MRA) and contained practical exercises on the WCO Corruption Risk Mapping, as well as a High-Level Dialogue Session participated by Dr. Mikuriya and Dato' Sri Khazali.



The High-Level Dialogue Session was opened with a key note address by Dr. Mikuriya, WCO Secretary General. He elaborated that Customs no longer hesitates to talk about integrity issues, which has led to the development of the Arusha Declaration. He said that it would be difficult to counter the problems without recognizing the nature and causes of the problems. Several prominent causes of integrity

problems include high tariff rates and complex Customs procedures. In this respect, Dr. Mikuriya touched upon the importance of the use of ICT and the human resource management, as well as the need for the engagement of the officials both of top management and working levels. He also encouraged overall government approaches. Dato' Sri Khazali, RMCD Director General, told about his administration's experiences in contending with the integrity issues through introduction of a set of countermeasures. Participants took advantage of the attendance of the WCO Secretary General and RMCD Director General and had an interactive dialogue.



ROCB A/P attends the A/P Vice-Chair's Office Opening Ceremony

28 July 2016, Suva, Fiji

On 28 July 2016, the Official Launching Ceremony of the WCO A/P Vice Chair's Office was held in Suva, Fiji, with presence of Honorable Mr. Aiyaz Sayed-Khaiyum, Fijian Attorney General and Minister of Economy, Dr. Kunio Mikuriya, WCO Secretary General, Dato' Sri Khazali bin Hj Ahmad, Director General of the Royal Malaysian Customs Department (RMCD). Around 50 other invited guests, including Fiji-based diplomatic corps and participants to the WCO Sub-regional Workshop on Integrity, which was held consecutively, and Mr. Kazunari Igarashi, Head of the ROCB A/P, attended and witnessed the Ceremony.



In the wake of the singing of the Fijian national anthem and the devotion, Mr. Visvanath Das, Acting Chief Executive Officer (CEO) of Fiji Revenue and Customs Authority (FRCA) and Comptroller Customs, made a speech in the capacity of new A/P Regional Vice-Chair. He expressed FRCA's honor to succeed the new role

or the next 2 years as the first WCO Member in the Pacific region to take over the important tasks, which would lead to raising the profile of the FRCA as well as other Member administrations in the Pacific region amongst the international Customs community, and reassured his determination to continue to foster close



communication and coordination among the regional Member administrations with a view to contending with a series of challenges ahead of the Customs community. Dr. Mikuriya, WCO Secretary General, expressed his confidence on FRCA to maintain and further elevate such important roles of the A/P Regional Vice Chair, and stressed the imperative needs for connectivity among relevant stakeholders, including Customs to Customs connectivity, to fulfill evolving roles of the Customs. Dato' Sri Khazali, RMCD Director General, offered continued support and collaboration with FRCA and wished all the best for the undertaking under the leadership of FRCA Acting CEO.



Honorable Mr. Sayed-Khaiyum, Fijian Attorney General and Minister of Economy, endorsed his political support for the FRCA to undertake the roles of the A/P Regional Vice-Chair for the next 2 years. Minister called for further enhancing international cooperation and collaboration in exchange of information and experience, as well as technical capacity building support from the WCO Secretariat and the regional WCO Member administrations. The Minister also touched upon the Integrity Workshop and reiterated the importance of integrity for upheaving the region's economic growth and securing the border from the threats posed by transnational organized crime and terrorism. In the wake of speeches, the A/P regional flag, which was officially handed over from RMCD to FRCA at the A/P regional consultation session held in the margin of the recent 127th/128th Sessions of the WCO Council, was unfolded and the plaque of the A/P Regional Vice Chair was unveiled.



WCO reaffirms enhancing collaboration with OCO

28 July 2016, Suva, Fiji

On 28 July 2016, at the invitation of the Oceania Customs Organization (OCO), the WCO Secretary General, Dr. Kunio Mikuriya, and Head of the WCO ROCB A/P, Mr. Kazunari Igarashi, visited the OCO Secretariat in Suva, Fiji. Mr. Seve Paeniu, Head of the OCO Secretariat, and his colleagues warmly welcomed the visit of the WCO representatives. WCO Secretary General appreciated the OCO for their continued collaboration with the WCO in capacity building delivery and outreaching of the WCO Instruments and tools in the Pacific region. In particular, Secretary General welcomed this week's collaboration for the consecutive organization of the sub-regional workshop on Single Window and the one on Integrity respectively, through logistical coordination between the OCO and the ROCB A/P. Mr. Paeniu of the OCO welcomed the Secretary General's first visit to

the OCO Secretariat and took this opportune occasion to give a briefing on the OCO's policy and priorities to the WCO delegation and consulted way forward collaboration towards future the based on existing Memorandum of Understanding. WCO fosters high-level support for the continued modernization of Samoa Customs

29 July 2016, Apia, Samoa

On 29 July 2016, Dr. Kunio Mikuriya, WCO Secretary General, and Mr. Kazunari Igarashi, Head of the ROCB A/P, visited Apia, Samoa, to pay courtesy calls to the Samoan political leaders with a view to calling for continued high-level support for on-going Customs reform and modernization of Samoa Customs, including expeditious accession to the Revised Kyoto Convention. In Apia, Dr. Mikuriya and Mr. Igarashi paid a courtesy visit to Samoan Prime Minister, Mr. Tuilaepa Fatialofa Lupesollai Aiono Neioti Sailele Malielegaoi, who warmly welcomed the WCO delegation that were visiting Samoa for the first time. Prime

Minister recognized the role of Customs for Samoa government with its revenue collection and border security functions and thanked the WCO for the technical assistance provided to Samoa Customs. Secretary General underlined the importance of simplification and of harmonization Customs with procedures international standards through early accession to the Revised Kyoto Convention (RKC),



which is expected to be approved soon by the Samoa parliament, so that the Samoa's economy may be well connected to the global trade. The Secretary General reiterated that WCO's relevant instruments and tools, including the RKC, would lead to increase Samoa's economic competitiveness as well as border security capacity, which the Prime Minister expressed interested in. In this respect,



Dr. Mikuriya encouraged the Samoa government to continuously engage in regional economic integration efforts through modernizing Customs procedures and practices. Prime Minister asked for the WCO's continued support for the Samoa Customs' capacity building to assist achieve this.



Prior to the courtesy visit to Prime Minister, Dr. Mikuriya and Mr. Igarashi met Samoa's Minister for Revenue and Prisons, Mr. Tialavea Fea Leniu Tionisio Hunt, and his Associate Minister at the Samoa Customs Headquarters. In this meeting, Secretary General explained the WCO's continued commitment to the Members' capacity building, especially for the

Pacific region, in order to support connecting the region's economies to the global trade chain and to counter transnational organized crime and terrorism. The Minister welcomed the delegation and expressed appreciation for the WCO's ceaseless support for Samoa Customs. Articulating a set of challenges the Samoa government and Customs are facing, the Minister asked for continued provision of technical training to Samoa Customs.

Taking this opportune occasion, Dr. Mikuriya and Mr. Igarashi were escorted by Samoa Customs Chief Executive Officer, Ms. Avalisa Viali Fautua'alii, for a tour to the Customs Headquarters and observed daily frontline operations in Customs clearance.



WCO Asia/Pacific Regional Workshop on Non-Intrusive Inspection

12-16 September 2016, Melbourne, Australia



The WCO, in cooperation with the ROCB A/P and the Australian Department of Immigration and Border Protection, organized the WCO A/P Regional Workshop on Non-Intrusive Inspection (NII) on 12-16 September 2016 in Melbourne under the sponsorship of CCF/Japan. A total of 30 officials representing 26 WCO Members, including the speakers from the host administration, participated in this Workshop. An Accredited Expert from the Dutch Customs participated in the workshop as the leading resource person and Mr. Kazunari Igarashi, Head of the ROCVB A/P, took part in it as the facilitator. Amid of the mounting concern around the world, this regional workshop was designed to provide a comprehensive understanding of the principles of the WCO SAFE Frameworks of Standard (FoS)



and the WCO's Security Package by examining the latest development of the SAFE FoS, good practices in the identification of high-risk containers through the application of a tactical risk management approaches, and the latest technologies available. Procurement and maintenance of the NII scanners was discussed. Participants were also briefed of the WCO's on-going initiatives in unifying the NII image file format and subsequent pilot on data sharing with a view to facilitating NII image data file among the Member Customs administrations, regardless of the

use of the different service providers, and developing the database into a possible training In the course of the module. Workshop, the participants undertook a site visit at the Melbourne NII facility, where the new large-scale NII scanner was installed recently, and observed ABF's NII practices as well as supplementary facilities, such as mini-laboratory and health and safety equipment.

12-16 September 2016, Kashiwa, Japan



The WCO in cooperation with the ROCB A/P and the RTC Japan organized the WCO A/P Regional Workshop on Post Clearance Audit at the RTC Japan (Japan Customs Training Institute), Kashiwa, on 12-16 September 2016 under the sponsorship of CCF/Japan. A total of 23 participants (22 officers representing the WCO Members and 1 officer from an Oceania Customs Organization Member), and 5 resource persons, including Mr. Takayuki Miyoshi of the ROCB A/P as a facilitator, participated in the Workshop.

The resource persons gave a comprehensive guidance on the international standards and conducted a variety of practical PCA exercises based on the newly developed WCO PCA Training tools. The participants shared their national PCA practices, actual cases, as well as challenges. Through this Workshop, the participants and the resource persons actively exchanged their views on PCA and the participants were able to obtain many concrete hints to implement/improve PCA in their respective administrations.
